2020-2021 Budget Vote June 9, 2020

Dear Community Members,

We hope that you all are well during the COVID-19 pandemic, a public health emergency unlike any endured for a hundred years. Public education was very different in Skaneateles a century ago, and due to the pandemic, school will be very different next year. Yet the passion of Skaneateles for students does not waver.

Although school buildings closed in mid-March, learning continues. Via remote instruction by our dedicated faculty, students continue to tackle their subjects. District parents graciously assume new roles supporting their children, with kitchens now acting as classrooms. Team-focused principals and coordinators work daily to bolster remote instruction and improvements. Essential staff maintain school buildings and grounds. The school now runs a meal program open to the entire community. We all know we can't truly be Lakers with the school empty. But if anyone ever did, none of us ever will take even the tiniest aspect of school life for granted again.

School construction on Project 2021 began before the pandemic, and work continues. Improvements will benefit our children long after COVID-19. Even so, due to high unemployment, lost tax revenue, and new costs, the next several years will be exceptionally challenging. Discussions are underway with all school parties. Since introduction of the tax levy cap a decade ago, the district has never exceeded the cap, with this year no exception. We request your approval of a \$34M budget at our tax cap of 2.14%. The budget is reduced by more than \$1M from last year. Even so, further cutbacks unfortunately are anticipated. Although we are less dependent on state aid than some schools and have limited funds in reserve, we are still highly susceptible to any and all reductions in revenue.

With public education now decentralized to far-reaching corners of the Skaneateles school district, new questions emerge every day. We don't have all the answers, nor will our next District Superintendent, Eric Knuth, who will start on July 1. The school will pledge to continue to spend carefully, embrace new ideas openly, use reserves smartly, target cutbacks sparingly and strategically, and ultimately emerge stronger wherever possible. We can only look to the futures of our newest Laker 2020 graduates. Although they enter an uncertain world, their energy and pioneering spirit will not fail them, nor will their legacy at Skaneateles.

Pursuant to Executive Order No. 202.26 issued on Friday, May 1, 2020 by Governor Andrew Cuomo, all voting for the June 9, 2020 election will be done by absentee ballot such that the school district must send absentee ballots with a postage paid return envelope to each "qualified voter." A qualified voter is someone who is a US citizen, 18 years of age, a resident of the District for at least 30 days prior to the vote, and not disqualified by any reason set forth in NYS Election Law §5-106. 

Salaries and benefits, as well as other operational costs of the District Office, each school's main office and the Board of Education


PROGRAM 68%

2020-2021 Estimated Revenues



The Skaneateles Central School District receives revenue to support its programming from multiple sources, as seen in this chart, with the proposed tax levy and New York State aid being the principal sources. State funding accounts for 19 percent of the district's projected revenue. The proposed tax levy of \$26,126,489, a 2.14% increase over the 2019-2020 tax levy (out of a possible 2.14%), makes up the remaining 77 percent of revenue.







2018-2019 Skaneateles CSD Regents Exam Results

Regents Exams provide a basis for evaluating the quality of instruction and learning that has taken place. Students must pass five Regents Exams in order to graduate and eight to receive the Advanced Regents diploma.





Scores on the ELA and Math assessments place students at one of four levels. Those at Level 4 excel in standards for their grade; those at Level 3 are proficient in standards; those at Level 2 are partially proficient and those at Level 1 are well below proficient in standards for their grade. The increased rigor of Common Core-aligned tests is apparent statewide as seen in the 3-8 graphs as well as in the Algebra 1 (CC) bar in the Regents Exam Results bar graph above.

On pages two and three, you were able to see the breakdown of the projected costs (expenditures), our income (revenue), and what we will need to support the difference (fund balance and reserves) for the proposed budget of \$34,037,540 with a total tax levy of \$26,126,489 for 2020-2021. An increase of \$548,363 or 2.14% in the tax levy is needed for 2020-2021.

So what is the community getting in return for the requested investments? We hope many features in this report answer that question. Here are some other examples of enhancements and improvements:

What Will You See When You Vote?

Qualifications of Voters:

- At least 18 years of age.
- Citizen of the United States.
- A resident of the Skaneateles Central School District for at least 30 days prior to the date of the vote.

Absentee Ballot:

Qualified voters on the most recent year's poll lists will be automatically sent an absentee ballot. Anyone who meets the definition of a "qualified voter," but does not believe he/she will be on the School District's poll list, please contact the District Clerk, Karen Dunphy, by e-mail at kdunphy@skanschools.org.

Proposition I

General Fund Budget

Shall the Board of Education of the Skaneateles Central School District, New York be authorized to expend the sum of \$34,037,540 for the 2020-2021 school year and levy the necessary taxes when due?

Proposition II

Bus Proposition

Shall the Board of Education of the Skaneateles Central School District, Onondaga County, New York, be authorized to purchase and finance four student transport vehicles, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$445,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$445,000, be issued?

Proposition III

Capital Reserve Fund General Construction

Shall the Board of Education of the Skaneateles Central School District approve a proposition to be determined by the District's voters to establish a new ten-year capital reserve pursuant to Section 3651 of the Education Law in an amount not to exceed \$2,500,000 to be used for renovations and additions to all District facilities, including purchase of equipment and school buses, security and safety improvements, technology upgrades, classroom equipment and/or school infrastructure equipment, site development, storm and sanitary sewer, driveways, and parking lots, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2020 and each fiscal year thereafter for the term of the reserve fund, (ii) future transfers of excess monies from Board of Education designated reserves, (iii) amounts of budgetary appropriations from time to time, and (iv) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law, be issued?

*This proposition is only to set up the reserve for future funding. The District does <u>not</u> intend to fund this reserve for the fiscal year ending June 30, 2020. This reserve can be kept for ten years and will be available for long term planning of future capital projects.

Getting to School Safely, Effectively & Efficiently

The continuation of our Bus Replacement Plan will be on the 2020-2021 school budget ballot (See Proposition 2). Cost savings measures like the Bus Replacement Plan help to accomplish our ultimate goal of providing the best educational programs for students, while being fair to taxpayers.

Now in year five, this plan involves the ongoing replacement of an aging fleet and will result in improved safety for students, improved approval ratings for bus inspections, and ultimately, fewer buses in total.

Board of Education: Candidates for Election (Vote For Two)

On June 9, residents will elect two members of the Board of Education to each serve a three-year term. Below are candidates that filed nominating petitions for the available seats:



Michelle Ederer

Michelle is the President of the Skaneateles Elementary Teacher Committee and has served on the board for the past four years in various roles. Michelle and her husband, Jon, have two children enrolled at State Street Intermediate School. Michelle recently earned her Doctor of Medical Science degree from the University of Lynchburg and practices as a Physician Assistant at WellNOW Urgent Care in Fairmount, New York. If elected, she will utilize her healthcare, grant-writing, and teaching experience to focus on instructional technology, curriculum development, improving the health, safety, and wellness of students for the district.



Daniel Evans

Dan has demonstrated extensive volunteerism in the community as a current Skaneateles BOE member, past Chief of the Skaneateles Fire Department, and coach for youth sports. Dan and his wife, Liz, have 2 children, ages 11 and 15, within the District. Dan has 23 years of professional experience in the positions of school administrator and teacher. Currently, he is a Vice Principal for the Syracuse City School District. Dan holds a MS of Education and Certificate of Advanced Study in School Administration from SUNY Cortland. Dan believes strong educational programming, supporting school personal, school safety and fiscal responsibility are key priorities to a successful district.



Gary Gerst

Gary was born and raised in Skaneateles and has deep ties within the community. A graduate from SCS in the class of 1990, he and his wife, Lynda, now have three children, a junior, a freshman, and a 6th grader, enrolled in the District. After earning his Certificate of Advanced Study, Gary was an Elementary Curriculum Coordinator, the Principal at Waterman, the Principal at the Middle School, and the Director of Learning at SCS. The 2020-21 tax levy would equal the 2019-2020 tax levy. The Administrative Component of the 2020-21 budget would be capped at 12.08% of the overall contingency budget, a reduction of \$54,430. The Program and Capital components of the 2020-21 contingency budget would need to be reduced by \$493,933 which would include cutting all equipment, the transfer from capital fund and potentially athletic expenditures. In the event of a contingent budget, the actual allocation of the components may differ from the budget displayed above.
