## GRIEVANCE PROCEDURE FOR ANTI- HARASSMENT AND ANTI-DISCRIMINATION (TITLE IX, SECTION 504 GRIEVANCE POLICY)

The Skaneateles Central School District is committed to creating and maintaining a working and learning environment which is free of discrimination and intimidation, based upon the principle that every individual is entitled to be treated with dignity and respect, and recognition that harassment and discrimination are a violation of law and the District's policy. The District strictly prohibits communication (verbal, written or graphic) or physical conduct that constitutes harassment or discrimination based on an individual's actual or perceived race, color, creed, religion, national origin, political affiliation, sex, sexual orientation (the term "sexual orientation" means heterosexuality, homosexuality, bisexuality or asexuality, whether actual or perceived), age, marital status, military status, veteran status, weight, ethnic group, religious practice, gender or disability. The District also prohibits harassment based on an individual's opposition to discrimination or participation in a related investigation or complaint proceeding under the antidiscrimination statutes.
