2023-2024 Budget Vote: May 16, 2023

Dear Skaneateles Family,

With the weather improving and some recent sunshine it is great to see Spring return to Skaneateles. For schools throughout New York State, the Spring also means the annual adoption of the school budget and budget vote to be held May 16, 2023. Included in this shareholder report are examples of how school district budget priorities align with our community driven Strategic Plan.

Throughout campus you can see the completion of Project 2021 where we continue to provide world class learning environments and facilities for our students. This summer, Project 2023 is set to begin with major improvements scheduled for High School science classrooms, updates and renovations to both our State Street and High School gymnasiums as well as improved site lighting, greenhouse renovations, new paving, and much more. Throughout campus we are also engaged in other necessary work you are less likely to see such as new technology upgrades, improved ventilation and HVAC equipment, water and drainage management and renovations to our transportation center. Phase 1 of Project 2023 is set to begin in June 2023.

In the classroom we are completing year 3 of our work in the science of reading and deployment of a vertically aligned ELA curriculum in grades K-8. The amount of collaboration and dedication required to continue this work has been nothing short of inspiring. We continue to build our capacity to provide high quality instruction and refine and evolve identification processes and delivery of intervention services for struggling learners. This work expanded throughout Pre-Kindergarten at Waterman where we are completing the first year in our pilot UPK program. In May, our next 14 UPK students will be identified for year 2 of this program with partial federal funding guaranteed throughout the 2023-2024 school year.

The social emotional needs and mental health of our students continue to be at the forefront of our work. During this school year services to children and families exploded on campus with new access to Helio Health, clinical counseling services, Access and Promise Zone, as well as preventative universal screening, all designed to identify and support students and families to remove obstacles to learning. Our dedicated team of teachers, counselors, school psychologists, social workers, service providers and administrators will continue to evolve and improve until every Skaneateles student feels safe, connected and supported at school.

On behalf of our entire faculty, staff, administration and Board of Education we genuinely appreciate the ongoing support that provides what each of our students need to be successful. This report outlines the ways in which we invest in the future of our children and explains the proposed 2023-2024 school budget. We invite you to attend our art exhibit to be held at our District Offices during the annual school budget vote and Board of Education election on May 16, 2023 from 7:00 am to 9:00 pm. 

Program: 66.18%


Program expenses for the District account for more than 66% of the overall proposed budget. Expenses in this category are directly related to and have an impact on classroom and overall instruction for our students. Examples of these expenses include, but are not limited to; teacher and support staff salaries, BOCES programs, social/emotional/mental health initiatives, deployed technology throughout campus, extra-curricular activities, athletics and professional development.

Capital: 23.27%

The capital section of the budget helps to support the overall operations, maintenance and security of our District. It also pays our debt that we have assumed through various capital improvement projects over the years. These projects help keep our facilities efficient, up to date and instructionally advanced to provide the best environment for our staff, students and community as a whole.

Administration: 10.56%

The administrative portion accounts for and costs the least out of the three categories in this proposed budget. Expenses in this section cover the overall administrative oversight of our District, curriculum coordination, professional development, various BOCES services and other Business Office functions and services.



Property taxes and state aid make up a majority of the District's revenues. In the proposed 2023-2024 budget these two sources account for over 92% of the budgeted revenues to help pay for our daily expenses.

Per the NYS Tax Cap Calculation, the District has a tax levy limit of a possible 2.26% increase. The 2023-2024 budget is proposing only a 1.99% tax levy increase which is below the tax cap calculation. This 1.99% increase generates an additional \$542,718 to help offset rising costs and contractual obligations.

Funding from state aid accounts for over 22% of the overall budgeted revenues. The District is seeing a \$437,238 increase from last year's budget. The reason for the rise in state aid derives from a small increase in foundation aid and increased BOCES aid.

In the proposed budget we are also incorporating more appropriated fund balance than we have in recent years. The significant increase is part of the District's Fund Balance Management plan to help invest in our priority areas and District objectives. Some of these include, but are not limited to; minimize the tax burden on our tax payers when possible, safety and security, district equipment, social/emotional/mental health, and instruction.




Disclaimer:

What Will You See When You Vote?

Proposition I

General Fund Budget

Shall the Board of Education of the Skaneateles Central School District, Counties of Onondaga and Cayuga, New York, be authorized to expend the sum of \$39,546,615 for the 2023-2024 school year and levy the necessary taxes when due.

Proposition II

Bus Purchase

Shall the Board of Education of the Skaneateles Central School District be authorized to purchase and finance replacement student transport vehicles, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$623,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$623,000, shall be issued.

Proposition III

Skaneateles Library (Separate from the school district budget)

Shall the sum to be raised by annual levy of a tax upon the taxable real property within the Skaneateles Central School District for the purpose of funding the Skaneateles Library Association be increased by \$14,560 to the sum of \$378,560 annually?

Library Proposition

This is separate from the school district budget.

New York State provides residents a direct say in local library funding via a proposition on their school district's budget ballot. Skaneateles CSD merely collects funds approved by the voters and disburses them to the library. The two (2) organizations' budgets are unrelated.

The Skaneateles Library is requesting an increase in its annual tax levy to offset operational expenses brought on by inflation and minimum wage increases. If the proposition is approved, the library's annual levy would increase from \$364,000 to \$378,560 – an increase of \$14,560.

What this Increase Means for Each Household

The following table illustrates what this increase would mean for a range of property values, as well as the new annual totals for these properties.

\$352,072 is the average and \$225,000 is the median property value in our district.

1. To elect or write-in two (2) members of the Board of Education each to 3-year terms, which will commence on July 1, 2023, or as soon thereafter as the individual may be sworn in, and expire June 30, 2026.

2. To elect or write-in one (1) member of the Board of Education to fill the vacancy left by the resignation of Tonya Coleman, to begin a term immediately following the certification of the election results and ending on June 30, 2023.

- Citizen of the United States.
- A resident of the Skaneateles **Central School District for at** least 30 days prior to the date of the vote.

Absentee Ballot:

Residents who will not be in the area on May 16, 2023 may apply for an absentee ballot at the District Office. If the absentee ballot is to be mailed to the voter, the application must be submitted at least seven days prior to the vote. If the absentee ballot is to be picked up by the voter in person, applications will be accepted until May 16, 2023. Absentee ballots must be received by the District Clerk no later than 5:00 p.m. on May 16, 2023.

The 2023-2024 tax levy would be equal to the 2022-2023 tax levy. The Administrative portion of the budget would be capped at the 2023-2024 proposed level of the overall budget. The Program and Capital portions of the budget would also decrease due to the cutting specific equipment purchases, transfer to capital fund for the annual Capital Outlay Project, no salary increases to employees not covered by a contract, other non-contractual items that are not contingent on an approved budget and any additional positions created by the defeated budget. In the event of a contingent budget, the actual allocations and expenditures may be different from the figures listed above.
